107-3 THE VIBE'S "NICKI MINAJ" CONTEST OFFICIAL RULES

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. If that caller answers correctly, they are the winner of the Prize for that Selection Day after providing the station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules.
