107-3 THE VIBE'S "JURASSIC QUEST" CONTEST OFFICIAL RULES

The Station will conduct the **107-3 The Vibe's "Jurassic Quest"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. At or around 6:30am CT and each weekday (each, a "Contest Round"), when the Station gives the "cue-to-call" sounder, (each, the "Sounder") listeners must call the Station at 816-744-1073. Caller ten (10) to the Station, as determined by the Station in its sole discretion, will give their answer for the trivia question. If that caller answers correctly, they are the winner of the Prize for that Selection Day after providing the station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. If that caller answers incorrectly, subsequent callers will be taken until answered correctly All entries may be played on the air. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
